Explanation of Responses:

- In connection with the consummation by ExlService Holdings, Inc. (the "Company") of its initial public offering, the Company will effect a two for one stock split (the "Stock Split") of all of its outstanding shares of common stock. The amounts in this Form 3 reflect such Stock Split.
- 3,750 of these options are currently vested and the remaining 3,750 will vest on January 1, 2007. Upon vesting, options are immediately exercisable.
- 2,500 of these options are currently vested, 1,250 of these options will vest on June 18, 2007 and 1,250 of these options will vest on June 18, 2008. Upon vesting, options are immediately exercisable.
- 5,000 of these options are currently vested, 5,000 of these options vest on September 29, 2007 and 5,000 of these options vest on September 29, 2008. Upon vesting, options are immediately exercisable.
- 10% of these options will vest on April 20, 2007, an additional 20% of these options will vest on April 20, 2008, an additional 30% of these options will vest on April 20, 2009, and the remaining 40% of these options will vest on April 20, 2010. Upon vesting, options are immediately exercisable.
- 50 percent of the shares of restricted stock vest on June 7, 2007 and the remaining shares vest on June 7, 2008.
