On June 15, 2020, at the Annual Meeting of Stockholders of ExlService Holdings, Inc. (the "Company"), the Company's stockholders voted on the following items: (1) the election of six members of the Company's board of directors (the "Board"), (2) the ratification of the appointment of Deloitte & Touche LLP as the independent registered public accounting firm of the Company for fiscal year 2020, and (3) the approval, on a non-binding advisory basis, of the compensation of the named executive officers of the Company ("Say-on-Pay").

<u>Proposal 1</u>. Each of the six nominees for election to the Board was duly elected to serve as a director for a term of one year, until the 2021 annual meeting of stockholders, or until his or her successor is duly elected and qualified in accordance with the by-laws of the Company.
